O prazo para entrega das obrigações contábeis e fiscais das empresas brasileiras está se aproximando.

A Escrituração Contábil Digital ("ECD"), que consolida a versão eletrônica de obrigações contábeis das entidades brasileiras, deve ser entregue até o último dia útil de maio, 31.05.2018, pela plataforma do Sistema Público de Escrituração Digital ("SPED"), referente ao anocalendário de 2017.

Por sua vez, a Escrituração Contábil Fiscal ("ECF"), que consolida as informações fiscais obrigatórias a serem reportadas às autoridades fiscais brasileiras, deve ser entregue até o último dia útil de julho, 31.07.2018, também por meio da plataforma SPED, referente ao ano-calendário de 2017.

The deadline to deliver the accounting and tax obligations of Brazilian companies is approaching.

The Digital Accounting Bookkeeping ("ECD"), that consolidates the electronic version of accounting obligations of Brazilian entities, should be filed up to the last business day of May, 31.05.2018, through the Public System of Digital Bookkeeping ("SPED") platform, regarding calendar year 2017.

On its turn, the Digital Tax Bookkeeping ("ECF"), that consolidates mandatory tax obligations to be reported to Brazilian tax authorities, should be filed up to the last business day of July, 31.07.2018, also through the SPED platform, regarding calendar year 2017.
